

Altarnun Parish Council "RO AN HAL"

DRAFT Minutes of **Altarnun Parish Council (APC)** meeting held at Altarnun Village Hall, Wednesday 1st March 2023 which commenced at 7.30 pm. **APC members present** Cllr Dowler (Chair), Cllr Bloomfield, Cllr Branch, Cllr Vickery, Cllr Pannell, Cllr Coles, Cllr W Smith & Cllr Wendon **Also present:** Cornwall Councillor A Parsons and nine members of the public.

32/23 Apologies for absence: Cllr Kendall, Cllr P Smith, Cllr Anderson, & the Clerk, R Turner (annual leave).

33/23 Members declaration of interests and requests for dispensations. No declarations of interests were made.

34/23 Invitation for members of the public/ward councillor to address the meeting.

Members of the public raised concerns regarding the speed of traffic on The Row at Fivelanes where traffic leaves the village to travel onto the A30 and produced a petition due to their concerns and a spokesperson on behalf of the group highlighted the hazards to pedestrians etc. They put forward some suggestions for dealing with the speed of the traffic and these including a new speed limit, closing the road off speed bumps, etc. Cllr Adrian Parsons suggested the installation of an average speed limit monitor which would also record the number of vehicles using the road subject to agreement by the relevant stakeholder.
