DRAFT Minutes of **Altarnun Parish Council (APC)** meeting held at Altarnun Church Hall (which was a forced change of venue on the evening), Wednesday 6th November 2024 which commenced at 7.30 pm. **APC members present:** Cllr Dowler (Chair), Cllr Bloomfield, Cllr Wendon, Cllr Vickery, Cllr Kendall, Cllr Pooley, Cllr Halls, Cllr Pannell, Cllr Masters & Cllr Smith. **Also present:** Mr R Turner (APC clerk) and twenty five members of the public.

156/24 Apologies for absence: Cllr Branch & Cornwall Cllr Parsons.

157/24 Members declaration of interests and requests for dispensations. Members declaration of Gifts and Hospitality. Cllr Vickery had declared a pecuniary interest in PA24/06705 to be tabled under agenda item 162/24 and agreed to leave the meeting when this business was being discussed.

158/24 Invitation for members of the public and Cornwall Councillor Adrian Parsons to address the meeting.

The chair introduced two representatives of Devonshire Homes who positioned proposals and timescales for seeking planning permission for in excess of 30 residential units and a children's play area as phase 2 of their development of Gratton Field, Five Lanes. Questions were raised by the public present regarding the proposed build quality as it was perceived there were numerous major failings in the phase one development. Also, during the phase one build, there were occasions when the main road was made impassable in day-time hours due to contractors plant and delivery vehicle movements. The Devonshire Homes representatives gave reassurances that build and working practices have changed and apologised to those affected by the initial build.

Former North Cornwall MP Dan Rogerson represented Ben Maguire MP (nonattendance due to Parliamentary commitment) regarding the National Highways outline proposals for the A30 between Kennards House and Five Lanes. Members of the public expressed their views in a forthright manner regarding the MP's stance, which to date did not appear to indicate his support for a grade separated junction at Plusha or the NH schemes tabled at the public presentation 26.9.2024 at Lewannick. Mr Rogerson committed to act as a conduit to strengthen community links with the MP regarding the proposals for Plusha junction and the other local A30 junctions.

Cllr Parsons had submitted a written report which the clerk read in precis. It contained all the details regarding the Cornwall Council budget for the financial year 2025/26, which in short, despite proposals to make £49 million of savings next year across the various directorates at Cornwall Council, the local authority still finds itself with a £9m gap in what has been described as "the most challenging budget" in the council's history. The leader of Cornwall Council has welcomed the budget, but says the fine details need to be understood and the funding allocations for Cornwall determined before its impact on the authority's finances can be fully considered.

The Divisional Councillors report also included full details of the weekly food waste collections and switching to fortnightly rubbish collections across north east Cornwall effective from 4.11.2024. Residents _have received new food waste caddies and rubbish bins or protective sacks for the service change in the area covers Bodmin, Bude, Launceston, Padstow, Wadebridge, Camelford, Kilkhampton and their surrounding areas. This follows the launch of the waste collection rollout in mid, south east and west Cornwall earlier this year.

The clerk advised that the full detail for both topics were published on the Cornwall Council website.

159/24 To approve the minutes of the APC Meeting held 2nd October 2024. It was proposed by Cllr Vickery, seconded by Cllr Bloomfield, then **resolved** that the minutes of the APC Meeting held on 2nd October 2024 were correctly recorded and that they be signed by the Chair. Cllr Dowler signed the minutes.

160/24 Matters arising from minutes of APC meeting 2nd October 2024 and not included in this agenda. There were no matters arising.

161/24 Finance Matters: The Responsible Finance Officer (RFO) reported: -

-Q2 2024/25 internal financial check had been completed, and no issues or concerns were identified. An updated finance report for the year to 30.9.2024 was circulated to APC members prior to the meeting and was reviewed at the meeting by the RFO. -Local Govt Services pay agreement was announced 22.10.2024. The clerks salary increase is 3.72% pa in cash terms based on prior 12 months backdated to 1.4.2024. For APC this means an additional 66p /hr payable or £198 pa.The figures are within the budget forecast.

Altarnun Parish Council supports this application because the site is not isolated from other existing development, and we believe the proposal is of a design that will mitigate the effects on the designated landscape and have no adverse impact on neighbours or their amenity. We note the scheme also includes plans to lessen the impact on the landscape by reducing the scale and height of the adjacent barn and that the remaining barn structure will be enhanced. Furthermore we note there have been no objections from neighbours.
